for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being unknown to the Grand Jury, did unlawfully, with malice aforethought, cause the death of Karter Ambrose, a human being, by beating said victim with an object the exact nature of which is unknown to the Grand Jury, contrary to the laws of said State, the good order, peace and dignity thereof.

WITH THE OFFENSE OF:

COUNT 2 FELONY MURDER

for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being

unknown to the Grand Jury, while in the commission of the offense of Cruelty To Children In The First Degree, a felony, did cause the death of Karter Ambrose, a human being, by beating said victim with an object the exact nature of which is unknown to the Grand Jury, which caused cruel physical pain to wit: a lacerated liver, and said victim is a child under the age of eighteen (18) years, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 3 CRUELTY TO CHILDREN IN THE FIRST DEGREE

for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being unknown to the Grand Jury, did maliciously cause Karter Ambrose, a child under the age of eighteen (18) years, cruel physical pain by striking said child with an object, the exact nature of which is unknown to the Grand Jury, which caused a laceration to said child's liver, contrary to the laws of said State, the good order, peace and dignity thereof.

WITH THE OFFENSE OF:

COUNT 4 FELONY MURDER

for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being unknown to the Grand Jury, while in the commission of the offense of Aggravated Assault, a felony, did cause the death of Karter Ambrose, a human being, by striking said victim with an object, the exact nature of which is unknown to the Grand Jury, which when used offensively against a person is like to result in serious bodily injury, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 5 AGGRAVATED ASSAULT

for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being unknown to the Grand Jury, did make an assault upon the person of Karter Ambrose with an object the exact nature of which is unknown to the Grand Jury, an object which when used offensively against a person is likely to result in serious bodily injury by striking said victim with said object causing a laceration to the child's liver, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT 6 MURDER IN THE SECOND DEGREE

for that the said accused, in the State of Georgia and County of Houston, between the 15th day of November, 2020, and the 17th day of November, 2020, the exact date of the offense being unknown to the Grand Jury, did commit the offense of murder in the second degree when the accused caused the death of Karter Ambrose, a human being, irrespective of malice while in the commission of Cruelty to Children In The Second Degree, by failing to seek immediate medical attention for said child for his lacerated liver, contrary to the laws of said State, the good order, peace and dignity thereof.
